August: Recognized as a Great Place to Work 2025 ranked #2.




Back to School Initiatives


- Donation of uniforms to pupils of St Theresa Catholic School, Epe

- July: Providus Fitness Day - A wellness-focused day encouraging healthy lifestyles.



- PROPAK West Africa - Session on Life Cycle Management for Sustainable Packaging Systems.



- **SEC Action:** Nigeria's Securities and Exchange Commission (SEC) considers phased adoption of global sustainability disclosure standards developed by IOSCO - International Organization of Securities Commission.

- **Global Alignment:** SEC confirms plans to adopt international sustainability standards in a locally adapted manner, ensuring Nigeria attracts more foreign investment while strengthening ESG compliance.
